Abortion in a Post-Roe Washington

In 1970, Washington State made abortion legal through 4 months of pregnancy. Before Roe v. Wade was ever passed, abortion was legal in our state.

Roe v. Wade called abortion a constitutional right and made it illegal for states to ban abortion before viability, which was considered at that time to be about 28 weeks. Now that Roe has been overturned, that ban is no longer in place meaning that states may restrict and govern abortion as each state sees fit.

Every year in Washington over 16,000 lives are lost to abortion as reported by the CDC.² This number does not fully represent all abortions that are happening in our state as only abortion facilities (not online abortion providers) are required to report the abortions they provide³. We expect the number of abortions to only increase as women flood our state looking for abortions or go online and order abortion pills.

In April of 2021, the FDA allowed the abortion pill regimen to be sent through the mail.⁴ At first, this was a temporary change due to the COVID pandemic. But in December of 2021, the FDA made this change permanent.⁵

We expect an increase in women getting at-home abortions. Currently, over 50% of abortions performed in the United States each year are medical abortions.⁶

Women who buy abortion pills online are never required to confirm their pregnancy at a physical clinic or receive an in-person consultation by a licensed doctor. As a ministry that cares deeply for the women of our community, we are concerned that the risks of at-home abortions will have disastrous effects on the health and safety of women.⁷

We are committed to continue what we've been doing for more than 40 years—providing free, compassionate, confidential, non-judgmental care to every woman who walks through our doors.

Care Net of Puget Sound is just a bunch of fake clinics and doesn't provide any real medical services.



As licensed healthcare facilities, we provide medical-grade pregnancy tests, limited ultrasounds, and STD testing.

Care Net of Puget Sound is a healthcare facility as defined by WA State RCW 70.02.010.

Everyone who performs ultrasounds in our centers is a licensed medical professional (RN, RDMS, ARNP, MD, PA) who has gone through a national training program and performed a minimum of 50 scans before they are approved to scan independently.

Our limited obstetric ultrasounds are designed to do three things:

- See if the pregnancy is in the uterus
- Detect the heartbeat (if present)
- Date the pregnancy

In addition, each ultrasound is reviewed by our medical director who is a board-certified, practicing OB/GYN.



Care Net of Puget Sound tries to trick women into thinking they're an abortion clinic.



We are open and honest in our advertising about the services we do and do not provide.

As a part of the Care Net network, our organization complies with strict guidelines regarding truthful advertising. Women asking for an abortion are immediately informed that abortion is not a service we perform.

Many women are uninformed about the procedure and the development of their unborn children. Women have the right to know all the facts related to the abortion procedure and to make a decision based on those facts.

We do NOT sell or distribute any patient information. We do not report women seeking out-of-state abortions. We do compassionately walk women through their options and offer them support.

When meeting with a woman considering abortion, our goal is never to “talk” her into choosing life.

We are here to provide emotional support, care, resources, and information on all her pregnancy decisions. A study of women who have had abortions found that 73% of them cited their reason for abortion as “I can’t afford a baby right now.”

Care Net of Puget Sound supports women, shares resources, educates them on all their pregnancy options, and seeks to remove whatever barriers that are convincing them that abortion is their only option.

Our medical staff is always committed to providing accurate information to our clients, no matter what their pregnancy intentions.

Our medical team is well trained on how to read ultrasounds to confirm the viability of the pregnancy, detect a heartbeat (if present), and date that pregnancy.

Only licensed medical staff who have completed ultrasound training from a national training institute and completed the 50 required supervised scans can perform ultrasounds in our centers.

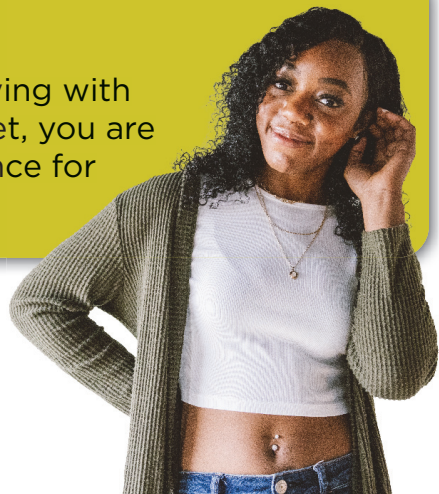
