Care Net Pregnancy & Family Services of Puget Sound served 14,964 people throughout our centers and programs with compassionate, practical, life-affirming care. In 2025, we performed 2,168 positive pregnancy tests, a 23% increase over 2024, and 1,931 ultrasounds, a 30% increase, giving more women the opportunity to see their babies and receive accurate information. Of women who saw their baby on ultrasound, 87% chose life.

Care Net of Puget Sound's commitment doesn't stop after birth. When a parent chooses life, Care Net walks alongside them beyond pregnancy, providing the ongoing support they need to build healthy, thriving families. In 2025, we provided 1,298 parenting classes along with

Smart Programs: Our healthy relationship education program, presented to 4,832 students in public and private schools on topics covering sex trafficking, boundaries and healthy relationships, STDs, teen pregnancy, and more.

Healing Tide: Our abortion recovery and pregnancy & infant loss ministry grew by 42%, providing healing and restoration 3,130 times to women, men, and couples.
